Call to Order

The meeting was called to order by Len Russell at 2:05 pm.

Year in Review (2021)

Conducted by Len Russell. Len thanked all Board Members and all the volunteers, especially those leading the activities, who contributed during a difficult year due to ongoing closures and restrictions.

Len reviewed the year, which saw the kitchen licensed and open for business, with several activities already taking place. Athletics had successes in Adult 3-pitch, Pickleball, Learn to Skate and Outdoor Hockey to name a few.

During the downtime some facility upgrades were possible including repainting the Main Hall, a Green Room and the installation of a patio railing.

Treasurers Report

With ongoing shutdown affecting revenue we were able to achieve a net income of +\$14k to offset the loss of \$11k last year. Emergency Wage Subsidy and stable City Grants made operation viable.

Forward looking

Len presented some key points moving forward.

- We need leaders to reflect our changing demographics,
- We must leverage all of our capabilities to provide programming, events and services, including the kitchen and hall utilization which are capable of generating revenue,
- Our web site & on-line presence need updating
- We must continue to foster collaborations such as:
 - Community Market (CBCM)
 - Carp Ridge Learning Centre (Day Camp)
 - o WC Legion 616, City
 - WOCRC (Youth support & programming)

Questions/Other Business

Councillor Eli El-Chantiry pointed out that with the upcoming municipal election any requests under City would be best submitted before July. Additionally he noted that some requests could be made for funds directly from his office budget.
